In January 2017, Gregory formed his own firm, GNFerraris, which today serves several not-for-profit organizations and municipal entities.

His broad experience in tax, auditing and consulting provides a unique global expertise to a diversified clientele in an array of industries. He particularly assists Peconic Landing in navigating through the complexities of new financial pronouncements and tax regulations, and the intricacies of not-for-profit and healthcare financial management.
